(Interior Walls) Minor cracks may appear with extreme humidity changes, particularly in winter when the heater is in use. Some sheetrock movement is due to past natural settling. We have continuously monitored, and no significant changes have been observed in the past two years.

(Driveways) Visible cracks present on the driveway, existing prior to purchase in 2023. No known structural concerns.

(Exterior Walls) Minor cracks present on the brick fascia near the guest room. Issue was observed at the time of purchase in 2023 and has remained stable. No known structural concerns; continuing to monitor.
