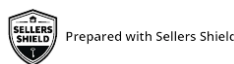

(Interior Walls)

A hairline crack above the primary bedroom door Has been sealed and repaired.

(Walls/Fences) One side yard gate is not functional

(Windows) Windows and home are original and double pane. Some glass show signs of aging and condensation.

One window frame in the gym has required re-caulking and sealing a couple of times over 13 years. A rare driving horizontal rain from the north side has caused small amounts of water to come in around the window. On two occasions leaked to the bedroom below. All repairs have been made.

(Previous Other Repair) Settlement cracks periodically repaired on decks.

(Settling)

Visible settlement cracks have been observed on the rear exterior decks. In one instance, a crack in the upper deck floor allowed water to drip through to the lower deck ceiling. These cracks were filled, and the ceiling was repaired. A similar issue with rainwater standing on the lower deck some years ago prompted him to install a drain pipe exiting from the side of the deck over the basement overhang mitigating the problem Some cracks have been monitored and/or filled/painted over the years.

(Water Damage) Drain installed on deck years ago to drain rain water that pooled In unlevel area on the deck.

*A single blockable main drain may cause a suction entrapment hazard for an individual.

"500-year floodplain" means any area of land that: (A) is identified on the flood insurance rate map as a moderate flood hazard area, which is designated on the map as Zone X (shaded); and (B) has a two-tenths of one percent annual chance of flooding, which is considered to be a moderate risk of flooding.

"Flood pool" means the area adjacent to a reservoir that lies above the normal maximum operating level of the reservoir and that is subject to controlled inundation under the management of the United States Army Corps of Engineers.

"Flood insurance rate map" means the most recent flood hazard map published by the Federal Emergency Management Agency under the National Flood Insurance Act of 1968 (42 U.S.C. Section 4001 et seq.).

"Reservoir" means a water impoundment project operated by the United States Army Corps of Engineers that is intended to retain water or delay the runoff of water in a designated surface area of land.
